- 1. The Secretary, Kerala Public Service Commission, Pattom, Thiruvananthapuram vide his letter read as 3<sup>rd</sup> paper above has advised 10 candidates for appointment as Block Development Officers in Rural Development Department on Rs. 10790-18000 (Pre-revised) under the method of Appointment by Direct Recruitment to the post.

- 4. The appointment of candidates named above are subject to verification of their age, educational qualification, character and antecedents and Medical fitness etc. The candidates will report for duty before the District Collectors/Assistant Development Commissioners (Gl) of the District in which they are posted within 15 days from the date of receipt of this order, failing which the appointment will be deemed as cancelled and no further claim in this regard will be entertained. The Assistant Development commissioner (Gl) will verify the Certificates in original in proof of date of birth, educational qualification,
- religion and caste etc. claimed by each candidate which are noted against their names above, before admitting them for duty. The candidate should also produce Medical Certificate as prescribed in GO (P) No. 20/2011/P&ARD dated 30.06.2011 at the time of reporting for duty.
- 5. The Assistant Development Commissioner (General) concerned should satisfy himself/herself as to the identity of each candidate before allowing him/her to join duty. For this purpose, the scanned copy of identification certificate of each candidate bearing the Serial Number in the Advice Letter received from Kerala Public Service Commission are forwarded herewith. The signature of the candidates on the passport size photograph affixed on the Identification Certificate should also be verified and the fact recorded on it. If there is any discrepancy, the candidate should not be allowed to join duty and the fact shall be reported to the undersigned forthwith. After the candidates are allowed to join duty ,the Identification Certificate since verified and found acceptable will be forwarded to the Accountant General, Kerala, (A&E), Thrissur by Registered Post for keeping the same under safe custody.
- 6. The Assistant Development Commissioner (General) concerned will verify the Non-Creamy layer Certificate produced by the concerned candidates before allowing them to join duty.
- 7. Since the selection to this post is made from a Common Select List, it is informed that in the event of discharge from service for want of vacancies, you may either re-register your name in the office of Kerala Public Service Commission, Pattom, Thiruvananthapuram and get

re-appointed on further advice by the PSC or you may wait for your turns for re-appointment to the post in the Department, if you desire to continue as probationer in the post from which you are discharged (vide Government Circular Memorandum No.3737/Rules-1/90/P&ARD dated 29.03.1990 and G.O.(P) No.7/91/P&ARD dated 15.02.1991).

- 8. The Assistant Development Commissioner (General) concerned will obtain the duly filled up Proforma for verification of character and antecedents of the candidate at the time of admitting him/her for duty and the same will be forwarded to this office without any delay.
- 9. The candidates appointed will be on probation for a period of two years duty within a continuous period of three years from the date of their joining duty. Also, they should pass the obligatory departmental test(s) within the period of probation, if not already passed.
- 10. This appointment will be subject to the final judgments in the cases pending before the Hon. High Court of Kerala.
- 11. The candidates appointed will have to undergo Orientation Training Course at SIRD, Kottarakkara as and when directed by the undersigned.
- 12. The Assistant Development Commissioners (General) will report the date of joining duty of the candidates appointed to this office in due course.
