- 4. The appointment of the candidates is subject to verification of their age, educational qualification, character and antecedents, Medical fitness etc. The candidate will report for duty before the District Collector/Assistant Development Commissioner (Gl), Kannur within 15 days from the date of receipt of this order, failing which the appointment will be deemed as cancelled and no further claim in this regard will be entertained. The Assistant Development commissioner (Gl) will verify the Certificates in original in proof of date of birth, educational qualification, religion and caste claimed by the candidate which are noted against the name above, before admitting him for duty. - 5. The Assistant Development Commissioner (General), Kannur should satisfy himself about the identity and signature of the candidate before allowing them to join duty. For this purpose, One Time Verification Certificate which includes the scanned image of photo and scanned image of the signature of the candidate is enclosed herewith. The signature of the candidate and the photograph should also be verified and the fact have to be recorded on the One Time Verification Certificate itself and should forward to this office by return at the earliest by the Assistant Development Commissioner(General).
