As per the proceedings read as 2<sup>nd</sup> paper above, 273 officers of the Rural Development Department were confirmed in the post of Block Development Officer as provided under Rule 24, Part II, KS & SSRs, 1958, in the substantive vacancies that arose in the Department, subject to the provisions under Rule VIII of Part II KS & SSRs.

Sri. Mathai. M.J, Assistant Development Commissioner and Sri. George Jacob, Deputy Development Commissioner have filed writ Petition before the Honorable High Court of Kerala for repatriation to the Administrative Secretariat vide papers 5<sup>th</sup> and 6<sup>th</sup> read above. As per judgment in WP ( C ) No. 237029/2008 dated. 10.06.2011 of the Honourable High Court of Kerala had ordered the repatriation of Sri. M.J.Mathai to Administrative Secretariat. Sri. George Jacob had obtained an Interim Stay on confirmation in the Rural Development Department. Hence the above officers are temporarily excluded from confirmation in the Rural Development Department.

In the stated circumstance the officers of the Rural Development Department as detailed in the statement shown as Appendix to this order are confirmed in the post of Block Development Officer as provided under Rule 24, Part II of KS& SSRs 1958 with effect from the date noted against their names subject to the provision under Rule 8 of Part II KS & SSRs and in pursuance of the instructions issued as per Government Circular read first.




