As requested by them they were repatriated to Rural Development Department and posted as Village Extension Officer Grade-I in Palakkad District vide reference 3<sup>rd</sup> cited under the provisions contained in Circular No. 2517/R1/2013/P & ARD dated 08-02-2013. Since their juniors have been promoted to the cadre of Joint Block Development Officer they are also eligible for promotion to that cadre. In the circumstances, they are notionally promoted to the cadre General Extension Officer/ Extension Officer(H) and then promoted as Joint Block Development Officer in the Scale of Pay of ₹ 16180-29180 under Rule 9(a) 1 of Kerala State and Subordinate Rules and posted to the stations mentioned against their names.
