**ORDER No: 19699/Estt.B3/2012/CRD Dated 19.09.2012**

In the Order read above the designation of Sri.E.Kamarudheen, (SI.No. 2 in the list of promotes) was wrongly shown as General Extension Officer, Mankada and was given promotion as Joint Block Development Officer(EGS), Nilambur in Malappuram district. On further verification, it has been found that Sri.E.Kamarudheen (Sr. Rank No. 721) has actually been working on deputation as Assistant District Mission Co-ordinator in Total Sanitation Campaign, Malappuram district.

In these circumstances, in partial modification of the order read above, it is hereby ordered that Sri.E.Kamarudheen, General Extension Officer on promotion as Joint Block Development Officer(EGS) is allowed to continue on deputation as ADMC, TSC, Malappuram.

In addition to this, the following senior most General Extension Officers/Extension Officer(H)s Gr.II are promoted to the cadre of Joint Block Development Officers(EGS/RH) in the scale of pay of Rs. 16,180 – 29,180 under Rule 28(b) of part II of the KSSR and posted to the posts/stations mentioned against their names.

The persons promoted shall not on any account, be retained in the present stations nor leave of any kind be sanctioned to them.
