Minutes of the daily meeting of the Covid LSGD war room held online.

HODs, Covid war room members, Mission Heads and senior field officers of LSGD participated in the meeting.

Decisions taken based on the discussion on the War Room Bulletin and on the concerned issues raised are the following:

- 1. KILA had been asked to do a process documentation of the LSGD war room. Presentation will be done in a week's time.
- 2. The ACS mentioned that there was information that covid positive patients in Parassala were unaware of the ward level Samithi. The Panchayat President is to be given the feedback that there are covid patients unable to connect with the Samithi for immediate intervention and rectification. Therefore awareness generation activities including mike announcements have to be strengthened. Interventions made by the Panchayat to this end are to be reported by DDP, Thiruvananthapuram.
- 3. The data on LSGs with high TPR as to whether clusters were formed and the number of clusters per was reviewed. Based on which, the following directions were given by the ACS.

Thiruvananthapur am		ACS expressed displeasure at the total discrepancy in the data presented with the previous information given, and the inability to provide succinct reasons for the same. The information given on cluster was therefore rejected and DDP directed to provide a clearer picture in the next meeting in respect of all the 6 panchayats.

Kottayam	Vechoor	Interventions made were noted. Constant monitoring is needed, so DDP to report on status again in the next meeting.
Malappuram	Ponnani	Considering the high number of cases in the municipality, admissions at DCC have to be raised. IEC activities need strengthening.
Malappuram	Pookottur, Thavanur	Will be reviewed in the next meeting to see whether the number of clusters have crossed 5.
Malappuram district		Reluctance of covid patients to move to DCCs was noted. Functioning of DCCs have to be intensified, and ensured that all houses with covid positive patients were identified that were unsuitable for home isolation and action taken to have such patients moved. Combination of IEC and firm action with the help of police needed.
Palakkad		 Displeasure of ACS recorded on the sweeping statement made that in actuality there were no clusters even though in 3 panchayats clusters were seen to have been reported. A clear report is to be given on the following in respect of all the panchayats in the reviewed list: The quality of functioning of ward level samithis – how many household clusters of covid positive cases identified? Of these how many patients of how many households have been

moved to DCCs or CFLTCs? What support is being given to the
other patients in home isolation in each panchayat?
 Do all these panchayats have either DCC or CFLTC?
 Admission status in DCCs/CFLTCs?
 How many queries are being received daily at their help
desks? Who is handling the covid related queries pertaining to health and treatment at the help
desk?
 All wards within containment zones should form clusters for
 follow up on covid cases. War room will cross check the data on word comitis and holp.
data on ward samitis and help desk for the concerned panchayats with the information
already available

4. It had been decided in the previous meeting to make necessary interventions to set up DCCs in areas with TPR 10% and more, areas where there is 70% occupancy in CFLTCs and areas with CSLTC, but no CFLTCs or DCCs. The ACS reviewed the updated status of the DCCs. The following Panchayats were seen to still require urgent intervention for setting up of DCCs – if houses have been used as DCCs, the cumulative number of beds were to be reported as DCC:

Insist on shifting the patients to the DCCs to avoid further spread.

4. Status of the community kitchen will be reviewed tomorrow. The war room should look at the status based on the list uploaded. Information on the presence of community kitchens, different categories of people who are actually in need and whether the existing kitchen identified is adequate should be updated before the next meeting by CM. All concerned DDPs and RJDs should give updates on the places that are found inadequate. Accurate information is expected, especially from Thiruvananthapuram and Palakkad.

5. Vallachira panchayats with TPR above 50% should be kept under supervision to see whether there has been proper intervention from the police force and the reluctance to go to the DCC has been resolved.

- 6. Trivandrum DDP should enquire and get updates on the reason for high TPR (above 50%) in Karavaram.
- 7. The DDPs of Trivandrum and Kozhikode should give updates on Poovachal and Peruvayal respectively.
- 8. Along with the district wise statistics of the TPR, the cumulative numbers of LSGs for the State should also be given.
- Identify the list of Panchayats district wise where the vaccine registration of frontline workers got rejected, the reasons therein and forward to the Director of Panchayats. The DP will look into the matter of HKS unable to get vaccine registration.
- 10.DDPs and RJDs to identify all LSGs that encountered crowd management issues at the vaccination centres in the last week in the district. Also to take a report on those places where spot registration has been happening in the past week (with dates on which spot registration was allowed in specific LSGs).
