Minutes of the daily meeting of the Covid LSGD war room held online.

HODs, Covid war room members, Mission Heads and senior field officers of LSGD participated in the meeting.

The war room was briefed on matters pertaining to LSGs arising in the CM's meeting on COVID management. Decisions taken based on the discussion on the War Room Bulletin and on the concerned issues raised are the following:

- 1. A government circular needs to be issued to ensure that all LSGs make necessary interventions to make sure that vaccine registration has been fulfilled in every household. Instructions specifically for planning vaccination drives, utilising the ward level samitis to facilitate registration and covering areas of poor vaccination coverage will be issued based on the notes received from Jagajeevan and the documented experience of Mulanthuruthy ward from KILA. (SS DC)
- 2. DDP Thiruvananthapuram should enquire about the overcrowding violating covid protocol in Vellarada fish market, Thiruvananthapuram.
- 3. DDP and RJD of Kottayam district should enquire about the overcrowding at the vaccination centres in the district.
- 4. The war room bulletin tracking LSGs with over 1.5 point increase in TPR consistently over 5 days was reviewed. The following LSGs where the TPR is consistently high were identified based on the following:
 - a. The TPR showed an upward trend or consistently high trend for at least 3 days without coming down significantly
 - b. Although TPR seems to have come down, the active caseload continues to be high
 - c. TPR is fairly high but active caseload is low, and the testing numbers are seen to be fairly low, which might be an indication of undetected cases

The LSGs so identified needed to be continuously tracked for the interventions made and the impact on TPR and active caseload:

- The strategies adopted by the above LSGs after the intervention and the briefing by DDP/RJD should be reported to the war room. The status of these panchayats and ULBs will continue to be monitored.
- Achieving vaccination equity is a new arena in which a joint effort is required.

The remaining districts' LSGs as per annexure 1 will be reviewed tomorrow.

General instructions to all DDPS and RJDs:

- a. Ensure the number of testing increases in LSGs with high TPR.
- b. Ensure higher rates of vaccination (especially if cumulative number is low) in LSGs with high TPR.
- c. DCC occupancy has to be pushed in these LSGs.
- 5. CM has instructed that those who test positive should be quarantined either at CFLTC or at DCC. Ensure that this is followed strictly.
- 6. War room should identify the consolidated list, district wise of Panchayats that are consistently maintaining a TPR less than 5% and active cases less than 50 for the past three days in descending order. (for all 3 days the TPR

should be less than 5 and the active caseload less than 50. Whether these LSGs had containment zones and had adequate vaccination should also be examined. Get the information by tomorrow morning. The War Room agreed to recommending to lift/reduce the lockdown restrictions in such areas.

- 7. DG KILA informed that presentation on the process documentation could be made tomorrow in the war room.
- 8. The ACS briefed the group on the actions to be taken to bridge the digital divide in respect of tribal school students in colonies with no or poor internet connectivity. Director Panchayats, DUA were asked to undertake an immediate assessment as well as to report on the reconstitution of PECs. DDP Kozhikode mentioned that the DC had taken a meeting to ensure the same.

The next meeting of the war room would be on 11.6.21 at 5.30 pm.
